Verification, Calibration and Calibration Report Explanation:

Verification Certificates:

Laboratories operating under LM-P-045-09-19 Standard, are accredited to issue Verification Certificates in terms of the Legal Metrology Act: 2014 (Act 9 of 2014). It is a legal requirement that any scale used for any trade related purposes must have a valid Verification Certificate.

Calibration Certificates:

Laboratories operating under ISO/IEC, Standard 17025 are accredited to issue Calibration Certificates under the authority and conditions granted by SANAS. These Calibration certificates are required by most Standards. Calibration is the comparison of a unit under test against a standard of known higher accuracy for the purpose of assigning a set of statistically derived values to the unit to within a 95% level of certainty, utilizing the actual values and uncertainties of the weights. The weights are traceable to the National Standard.

Calibration Report:

Where only accuracy and traceability are required, we can issue a Non SANAS Calibration Report that will report only nominal comparisons to mass pieces traceable to the national standard. This is not under the auspices of any Standards.
